Board of Trustees

I continue to be acting as Chair of the Board of Trustees until our external Chair is recruited. There has been one further Board meeting as well as numerous forum discussions. Several requests for use of discretionary funding have been approved, including ones for attendance at Associate Lecturer Staff Development events to promote awareness of the Association amongst ALs, and a plan for a Volunteer Celebration dinner in the summer.

Strategy

The Association has started work on reviewing its strategy. The project progress is being overseen by the Strategy Project Steering Group. Work so far feeding into this includes a student consultation, a survey of Central Committee Representatives and Senate Reference Group, and workshops with the Central Executive Committee, Trustees and the Association's staff team, including a Strategy Development Weekend in March. This is now being taken forward by a series of working groups.

REPORT OF THE DEPUTY PRESIDENT

President, I realise time is flying by and the Central Executive Committee (CEC) of 2018 – 2020 are a 3rd of the way through our term. You can read some of 'highlights from our first 6 months' highlights here.

I am grateful for the continued support from Wendy Burrell (Deputy Chief Executive) and continue to work closely with Cath Brown (President). I have monthly team meetings with Cath Brown, Rob Avann and Wendy Burrell and regular catch-ups with other members of the CEC. I have had the pleasure of attending some fantastic events and one-off meetings, some of which I will describe in this report; as well as my regular and quarterly meetings (listed at end of report).

I have given some 'Adobe Connect Training' to the new Chair of PLEXUS and some Club admin and have held a couple of 'Ad-Hoc Refresher Adobe Connect Training' on request. During the absence of a Vice President Community, I coordinated/hosted 'Community Drop-in Sessions', supported some of the 'Community' work (e.g. 'Clubs', 'Residential School work and 'Freshers' events).

Freshers was held between 21st January and 1st February 2019. I attended the 'Welcome to the OU Students Association' Facebook event and hosted as 'Freshers Special Community Drop-in Session. I supported each of the Faculty Association Representatives (FAR) in their individual 'Faculty Freshers Events' for WELS (Wellbeing, Education and Language Studies), FASS (Faculty of Arts and Social Sciences) and STEM (Science, Technology, Engineering and Mathematics). In the absence of FAR for FBL (Faculty of Business and Law) I co-hosted an 'FBL Freshers Event' with other Business or Law Central Committee Representatives (CCR).

The result of by-elections was announced on 13th March 2019. I would like to take the opportunity to congratulate our new Vice President Community 'Anca Seaton' and our new Faculty Representative for the Faculty of Business and Law 'Matthew Porterfield'; along with our new Student Trustees 'Adelaide Ribaud', 'Cinnomen McGuigan' and 'John Paisley'. I am looking forward to working with them on the CEC and BOT (Board of Trustees) respectively.

I attended a 'Strategy Development Workshop' on the 2nd and 3rd March 2019 along with other CEC members, Trustees and Association Staff members. We reviewed the Students Association vision, mission and strategic focus areas. We looked at emerging themes through feedback previously received (e.g. freshers, student consultation forum, student representative surveys, association forums etc). The project has moved on to look at key strategy areas which has been divided up into smaller working groups and I have been given a place on the 'Student Support' Working group'.

Representation Review

I continue to work with Peter Cowan (Vice President Education) along with Sam Harding (Head of Student Voice) on a full review of 'Student Representation' (specifically 'Central Committee Representatives'). We have been collating and analysing the feedback from the Committee Staff Survey, OU Staff Survey and Central Committee Representative Survey; and will be releasing the OU Student Survey to the wider student community shortly. [further information in 'representation review' CEC Paper]

Postgraduate Research Students (P G R Students)

I regularly attend the 'Postgraduate Research Students - Graduate School Liaison Group' (PGR - GS Liaison Group) to discuss PGR issues, provision and work. On the

5th February 2019 I attended a PGR Induction for on the for the February intake of PHD Students. I have regular meetings with Amy Fergusson (Projects Officer, Community) to plan our work for postgraduate research students.

We have planned some pilot themed events for PGR students, working alongside the Graduate School and specific OU units. We hosted our first themed PGR Student event on Careers and Employability in the hub on campus; which was supported by the Careers and Employability Service, Personal Development Unit and the Graduate School. 20 PGR students attended and were able to get free 'headshot' photographs taken be a professional photographer (funded by the Graduate school) that then can use for their research or career profiles. Our second themed event on 'Equality, Diversity and Inclusion' is planned for the '25th April'.

Volunteering Update

In January I attended some planning sessions for our 'pilot' student led homelessness project called 'Donate & Donuts'. This project was led by Sarah Jones our F A R (Faculty Association Representative) for WELS (Wellbeing, Education and Languages) and held in Milton Keynes on the 28th January 2019 from 2pm until 8pm. It was a successful event attended by over 100 people and we collected over 2500 items for the homeless. We spent the next day counting our collection and organising the items for distribution to Bus Shelter MK, MK Soup Run, Help our Homeless MK and the MK Winter Night Shelter.

Work is continuing on the 'Investing in Volunteers' accreditation and we are on track for a submission to panel I July 2019. Heather Allen N C V O (National Council of Volunteer Organisations) will be starting face to face interviews about 'volunteering at the association'; the interviewees will be randomly selected from volunteers, staff and trustees. We have had a successful submission for CAN Conference on 'Investing in volunteers', the feedback received through this activity will feed into this work. We have received approval from the Board of Trustees for Discretionary funding for a 'Volunteer Celebration Event:' to be held in June 2019 (date to be confirmed). [Further volunteering updates can be found a separate 'Volunteering' CEC paper]

Culture Review

We have had a successful submission for CAN Conference on "Engaging Students in Change - Culture Change Workshop", the feedback received through this activity will feed into this work. JISC CAN Conference 2019

Change Agents' Network (CAN) Conference 2019 around 'The Evolving Landscape of Staff-Student Partnership' on the 29–30 May 2019 is being held at the OU Campus for the first time. There will be Representatives from all areas of Education from across a variety of Establishments, with contributions from colleges and universities. I put together 2 submissions around Culture Change and Investing in Volunteers, they were both accepted and are part of the conference programme.

- 1. "Why 'Investing in Volunteers'?" We will be discussing ideas and working together on how to shape future success for our volunteers. The main workshop will focus on understanding the best ways to 'invest in students as volunteers', to help students position themselves for success.
- 2. 'Engaging Students in Change Culture Change Workshop' We will work on key areas to understand/improve current culture and address areas of concern; identifying ways to work with students to create a unified ethos, build motivation and effect positive change.

I will co-presenting Billy Docherty's (FAR FASS) CAN Conference submission 'Diversity in Education'

Student Experience Discussions

I have been hosting dedicated monthly 'Student Experience Discussions' sessions with Amelia Gackowska (Vice President Student Voice); which is an opportunity to hear about the student journey and the different experiences that impact it, both positively and negatively. Feedback will be collated from general areas of concern, and added to other 'Student Experience' feedback collected through a New dedicated student-focused 'Student Voice' Forum and New 'Student Voice' Feedback Form (which can be anonymised).

This feedback will be considered and prioritised (e.g. items of concern or to celebrate success from across the wider student body). They will be added to a 'Student Voice' information paper, which will be added to the Agenda of the 'Student Experience Committee' (a mid-tier governance committee) for discussion. We will be sharing this paper with the wider student body and then extract the relevant information for the Student Voice section of our website and close the feedback loop for students. This feedback may also be channelled into other specific areas too, to inform the work of our Student Representatives and shape our Student Voice Work. Amelia and I are coordinating this work, with support from the OU Students Association Student Voice Staff Team.

Future sessions will be held on the 1st of each Month at the same time (7.30pm - 9.00pm) in our dedicated <u>Student Voice Adobe Connect room</u>. Please get involved, get your 'Student Voice' heard! The more students that feedback, the more evidence we have to share with the University.

REPORT OF VICE PRESIDENT ADMINISTRATION

It has not been long since the January meeting of the Central Executive Committee (C E C) but there has been a fair amount happening as regards the Student Association, some of it very public as you will see from the other Officer reports and some more behind the scenes which certainly describes the VP Administration role.

The most important dates in my diary have been taken up by two subvention meetings. The first of these meetings were with Chris Rooke, Director of Academic Services and then with Liz Marr, Acting PVC Students. Unfortunately, before anything could be agreed we had to bring Liz up to speed with university block grants (Subvention process) and how the Association worked. Nevertheless, these meetings went very well thanks to the support from Alison, Rob and Cath. It looks as though we have the three years subvention deal back on the table and they have agreed to put in writing that the University will back us should anything go wrong.

I took part in the joint Trustee-CEC strategy weekend and have subsequently been appointed to the working group concentrating on relations with the OU as part of the strategy development. I have been working on the Elections review and looking at a CEC Code of Conduct both of which are the subject of papers to be delivered at this meeting. There are also a couple of amendments needed to the By-laws and I will bring these changes to the CEC and Trustees for discussion and approval at a future meeting. I also discussed changes to the Volunteering Policy with Head of Student Volunteering, which you will hear about at this meeting.

I took part in the Student Consultation at Milton Keynes on March 22nd and the afternoon went down very well with the students. We gained a few ideas from them and it was a very valuable exercise hearing different students views from also areas of their journey with the OU. I believe a paper will be issued in the near future.

I took part in a meeting discussing the student voice website, which was very enlightening. You will hear more about this from other officers' reports. I also took part in a workshop on improving PG induction resources and experience, as a student rep who is currently studying for an MA. This was very useful as I was able to input my experience as a graduate becoming a post graduate student, what I found helpful and what was not so helpful, it turned out that there are a lot of really helpful resources out there, but the students are not necessarily aware of them. The Library will create a page on the website where all the necessary resources will be linked. There was also talk of PG student taking part in a video. They have asked for volunteers I have been tasked with trying to find PG students interested in helping out. I still have a few things to iron out like expenses, but I will be putting a notice on the forum for anyone who is interested. When I have more details, I will let you know.

I have attended a Trustees meeting and various online discussions. Full details are available in the minutes and the Trustees report to the CEC.

I was unable to attend the Societies meeting, so I am waiting for the minutes to let me know what happened, but in the last meeting we were being very proactive with helping them to get up to speed with their compliance with the Data Protection Act . I have attended meetings with OSL and OUSET.

REPORT OF VICE PRESIDENT COMMUNITY

This is my first report as Vice President Community. It covers a sort period of time, from 13th March (elections results being announced) to 9th April, 2019 (time of writing).

After the initial euphoria after the elections results were declared, the panic set in. There was a flurry of emails about Induction, writing a profile for the website, completing training courses, etc. Being on the Central Executive Committee isn't new to me, but I noticed it is harder to make a start while everybody else is in full flow. My previous experience on the CEC helped me get up to speed in most areas and plan my activities for the next few months and beyond.

Induction

As touched briefly above, I attended an online Induction session run by Beth Metcalfe, our Head of Volunteering. It was a novel experience for me, as I was in a noisy service station somewhere on the M5. It went really well and it got me up to speed with the latest changes in the Students Association staff and my own position.

OSL (OUSA Services Limited) aka OU Students Shop

I attended a face to face meeting of the OSL Board of Directors. We discussed the changes in the postal charges calculation for international orders, reviewed the existing board membership structure and the warehousing charges for processing of orders and graduation ceremonies. We also discussed the current financial position and agreed on the next steps, and took into consideration the decisions made in the online part of the meeting the week before. But by far, the most exciting part of the meeting was about the OU 50th Anniversary Project run in partnership with the OU Development Office. We had the chance to see the new merchandise celebrating OU's 50th birthday, which is going to be available in the webshop soon. Keep your eyes peeled!

OU Student Consultation – London

I attended the OU Student Consultation meeting in London with VP Media and Campaigns, Fanni Zombor. It was a good meeting, the facilitator kept the discussion on topic and encouraged students to contribute to the meeting. The afternoon session was a presentation of the Students Association, who we are, what we do, how we support students and create a vibrant student community. I am pleased to report that almost all students stayed for the afternoon session, were very interested in what we had to say, used the "Student Idea" cards to let us know if there was anything they wanted us to do, or wanted more information about meetups, for example, or how to get involved.

Community Drop Ins

I carried on the online Community Drop In started during Steph Stubbins's term. There were some teething problems (mainly due to my laptop deciding to do its own thing, and not what I wanted). My aim is to try and introduce themes to these drop ins, as a conversation starter. I would like to involve other aspects of the Students Association, for example clubs and societies, or tips for a healthy body and mind, etc.

Student Community Working Group

The Central Executive Committee have several working groups covering the different areas of our strategy. I am the CEC lead in the Student Community Working group, together with other CEC members and also members of staff. The forum has been set up for us, and we are now starting the discussions about finding three strategic objectives, find the stakeholders and think about any additional insight/data/research we need to add in order to support our strategic goals.

Bath Residential School

The Bath Residential School runs for 5 weeks from 6th July, 2019. The Student Association will have a team of volunteers each weekend (usually one lead rep and 2 resi school volunteers), and they meet and greet at registration, have a short slot in the plenary to tell students about the Students Association and our activities at Bath, also run a merchandise stall and the quiz.

The call for volunteers for the Bath Residential School will go out towards the end of next week (w/e 21st April, 2019) and close three weeks later.

REPORT OF VICE PRESIDENT EDUCATION

It has been a busy three months since the last Central Executive Committee (C E C) meeting with many internal and external meetings attended as well as the usual C E C business which goes on between meetings.

Meetings attended were:

Curriculum Forum (Monthly)

This considers the institutional aspects of curriculum and its sustainability as laid out in the curriculum plan. Items discussed in this quarter included Employability in Curriculum (in response to the Enhancing Employment and Career Progression working group), Flexible Study Intensity and discussing the Membership and Terms of Reference for the Curriculum Portfolio Panel which will replace the Forum from May. This will be the advisory group for the Vice Chancellor Executive (Academic) and will, after some concerns expressed over the initial membership, include a student rep (V P Education) in the main panel.

FutureLearn Postgraduate Courses (Monthly)

This is in a 'test and learn' phase until Spring 2020. The first module, H880, is in progress and it is envisaged that three more (two from F B L and one from FASS) will be started in Autumn 2019. These three are due to enter academic governance as part of the module approval process shortly.

Quality Monitoring and Enhancement – Board of Studies Reports and Review Meetings.

This has been part of an ongoing project to review the process and to identify areas where students can play an active part in developing these. Some recommendations will go to the Student Experience Committee and Cath, Steph and I were able to comment on the institutional report draft before it goes to that Committee.

Middle States Commission on Higher Education Accreditation (monthly) -

Meetings to date have been held to draft the self study document which will be presented to the accreditation panel. As well as my comments as part of the working group, a workshop was held after the January Senate Reference Group meeting and comments from there were also fed into the latest draft document.

Post-Graduate Research Student / Graduate School Liaison (monthly) – we have discussed issues arising from Post-graduate research students and provide support as needed.

Senate Reference Group / Senate (quarterly)

A fairly quiet agenda for the most recent meeting but that did not get in the way of a long discussion over the Academic Performance paper in particular. A new and clearer format made it easier to identify areas for discussion at both S RG and Senate. The S R G meeting was helpful in providing the student members of Senate with ideas to carry forward to the full meeting where, among others, we highlighted the recording of tutorials, student representation on the A L Contract implementation teams and taught postgraduate fees.

Student Experience at the end of Module (SEaM) working group (monthly)

I was invited by Cath to join her on a sub-group of this relating to the questions about tutors as part of the wider review of SEaM. We have reviewed the questions and made some short term recommendations for this year only. A more detailed review is needed for permanent changes.

Other Projects and Meetings

I was also invited to attend some demonstrations of potential replacements for the electronic submission of T M As and exams (setting and marking) and attended the meeting to produce the high level requirements for the latter. At the time of writing the final meeting of this phase, the assessment of the exam systems, is still to take place with a final report to go to the Vice Chancellor's Executive at the end of the month.

Within the Student Voice Team I attended the Research Seminar on March 7th where some details of a student led research project were presented. I also took part on a discussion panel at the end of the session. I also attended a Central Disciplinary Committee (C D C) Rep Development Day where C D C reps identified areas for better support of student reps involved on this committee and also a discussion session with the Head of Student Casework which included practical issues such as student attendance at these meetings in person. I took part in the 'I am a student rep' session both in the video Q & A session and inviting the P V C Students to take part – which she was happy to do so answering questions on the value student reps add to the University.

The main ongoing project within my remit at present is the Representation Review and a paper highlighting progress to date is part of the C E C agenda.

I was, along with Cath, a student rep at the University's face-to-face consultation in Bristol and was delighted with the turnout. A clear vindication of comments made by Association reps in the South West regarding the lack of such opportunities in the past. It was a good day with a lot of interesting discussion and valuable comment regarding the Association collected by the Student Voice team.

I have also held regular catch-up sessions with Sam, Allan and Hannah either during my visits to campus or via Skype. As Chair of CAP I have had discussions with the Head of Operations regarding the upcoming forum review and this is also summarised in a paper to the C E C.

And not strictly within my remit but one of the most enjoyable volunteer roles within the Association I attended the Barbican Graduation ceremonies on March 22nd and 23rd.

External Events

It has also been a busy time for external events. It is important that, as an organisation, the Association has a visible profile in the Higher Education sector. One way to do that is to be there at National H E events and many C E C members have been involved in these.

My contribution has been:

Quality Assurance Agency Enhancement Themes – I attended a one day conference in Edinburgh looking at how students can use data to support their representation to their University.

The Student Engagement Partnership – Cath and I (as students) and Pooja and Sammi (as presenters) attended this conference which was looking at how student representation and partnership can enhance the student experience.

Quality Assurance Agency Grade Inflation Consultation Workshop – this is currently a 'hot' topic as the number of 1st class and 2:1 degrees awarded across the Higher Education sector has risen dramatically since 2012. There are varying reasons for this but in order to ensure credibility that a qualification and its grade remain meaningful the Q A A led a consultation into this and a Code of Practice for higher Education Institutions to ensure public confidence in the quality of degree awards. Subsequently Cath, who also attended, and I drafted a formal response to the consultation.

REPORT OF VICE PRESIDENT EQUALITY & DIVERSITY

This Report briefly outlines my activities since the date of my last Report to the C E C. Note: Unfortunately, since my last report, my husband and I are still dealing with the sad news we received in December and are also now going through the process of selling and buying property for my 92-year-old Mum. Therefore, my work for and on behalf of OU students has (and is) rather patchy so this report is a brief one and only contains ongoing items and brief details of activity for January, February, March and upcoming commitments in April 2019.

The OU's Race Equality Charter Mark Application

This application was due to be submitted in February 2019 but due to a low response to both staff and student surveys, this has now been pushed back to July 2019. New surveys have been sent out and I'm attending meetings via Skype and on Campus when I can. Ongoing.

Mental Health Awareness

The OU and the Students Association are very keen to promote the importance of students' mental health wellbeing and the support that's available. A first meeting took place in July 2018 and VP Student Support and I have had a couple of meetings since then with the OU. Unfortunately, the person we were liaising with in the OU has retired so we're meeting with the new person at the end of April to further discuss the ways in which we can work together on this important issue. Ongoing.

Students in Secure Environments (SiSE)

Currently working with the SiSE team on a 'study buddy' project and reinstating the issuance of a redacted copy of the OU Students Magazine which can be sent to OU students in secure environments. Also, having discussions with the SiSE team about working with the Prison Reform Trust to explore how organisations promote opportunities for people with lived experience of prison. Ongoing.

The Open University's EDI (Equality, Diversity and Inclusion) Objectives

There are a number of these which are currently being re-written. The link to the OU's Equality page is here for more info. A couple of these objectives which I'm directly involved in are:

Objective 1c – Improve equality declaration data for students

The rationale for this OU-led 'Objective' is to improve the monitoring data to allow the OU to measure participation and outcomes for students across a wider range of characteristics and circumstances. The OU says: 'This will help ensure that all individuals, especially those who have not declared their status on their student profile, feel able to access and participate in their learning experience with the OU. Ongoing.

BaME – Black and Minority Ethnic students

Because of the degree-award-attainment gap in respect of BaME students, I'm involved with a number of activities on subject. I attended an all-day workshop last July which

focussed on ACCESS students and this issue was promoted during Black History Month last October by the Association's Student Support Team. Ongoing.

Assessment Exceptions Group – Disability/Reasonable Adjustments

Was invited to join this group by Peter Taylor - Professor of Organic Chemistry STEM, Life Health & Chem Science – after working with him on the Open Board of Studies committee. Prof. Taylor heads the team who work with students across all Faculties who submit special circumstances forms after an exam or EMA (End of Module Assessment). Ongoing.

REPORT OF VICE PRESIDENT MEDIA & CAMPAIGNS

The Hoot

The relaunch of the OU Students Magazine was by far the biggest project I was involved in/ leading on over the last few months. There is already some information in my previous report on the first steps of the Magazine. After the approval from CEC, most of January was spent by exploring the WordPress tool and site builder to create a basic site which could then later be changed and shaped to our needs. It was clear that the space was primarily for students to engage with each other. After the site was built, I then went to the CEC on our forums to ask for feedback on different parts of it every week. With their feedback, and the involvement of those who initially signed up for the development project, we shaped the Magazine to make it appealing to students with the help of a Magazine project staff team, who carried out the operational bits. This mainly took place in February through to mid- March.

Whilst the design was being done, other aspects of the project were started as well. This included the privacy policy, setting up social media accounts for the site, creating a newsletter for the site, writing the submission and writers' guidelines, making the site accessible, testing it for any issues and creating the gamification for the site. A group of staff and myself worked on these bits.

After finishing the majority of the above work, the site was opened to CEC, groups and societies for testing on the 22nd of March, which allowed for any last minute changes to it.

At the time of writing this report, The Hoot (https://thehootstudents.com/) has just been officially launched and we've had 345 users and 1,196 views on the first day. More information on the first few weeks of statistics will be shared with the CEC on CEC weekend.

The second phase of the project will begin soon, which will include more testing of accessibility and setting up some other functionalities on the site as well as looking through everything we have done so far.

DiSC Implementation Group

I have been a regular attendee of this group. It looks at the bigger picture in term of digital skills both for staff and students. The group works to find ways to help people gain the necessary skills they need for their studies life and employment. It also takes part in finding ways to reach people to let them know these opportunities are available and tries to find other parts of the University where there is already some of this skill training happening.

CSR Staff and Student Reference Group

I am one of the student representatives on this reference group. We receive updates about the different elements of the project and are provided the opportunity to challenge and question the product owners as well as suggesting direction for the project.

CSR eTMA and exam demos

I have been asked by Cath Brown to attend a demo for both of the systems. Throughout the sessions we found out about the company, the product they had to offer us and we were given the chance to question functionalities important to us about all the software. Apart from the demos I attended, there were other sessions involving different product

owners, and Cath attended the wrap-up session for the eTMA system while Peter Cowan attended the exam logistics one.

Campaigns and External Engagement working group

After the Strategy Weekend in March, I have been appointed to be the CEC lead on the campaigns and external engagement working group alongside Sam Harding from the staff team. At the time of writing this report discussions have just begun, but the working group is due to give an update on the key focus area later on in April CEC weekend.

London Student Consultation

I attended the London Consultation event in March with our newly elected VP Community. During the day we discussed various subjects including plagiarism and assessment. There was a wide variety of opinions which made the discussion quite interesting and we also had the chance to promote some of the work we do for students. Overall, we received good feedback about the work we do and got some good suggestions on other activities the Association could run.

CAN Conference at the OU 2019

The CAN Conference this year will be held at The Open University. I am the nominated student to take part in the decision making and shaping of the conference. The conference has the theme of the staff-student relationship. As part of the panel, we judged the proposals and decided which ones will be accepted to present at the June conference.

As part of the conference at the time of writing this report, we are recruiting students to help on the 2 days in exchange for having the opportunity to participate in the conference as well.

Student Panel at CAN Conference

I have been very kindly asked to lead on the student panel discussion at the CAN Conference 2019. The student panellists are yet to be confirmed, but the discussion will be focusing on the meaning of staff-student partnership for students and how consistent students' experiences are in this area.

Changes in my staff team

Kate Dungate, current Head of Digital Communications will be going on maternity leave in mid-April and our current member of staff, Heather Bloomer will be covering the head role in Kate's absence. The team is still recruiting for the technical officer role (now renamed Digital Communications Optimisation Officer) and they will begin interviewing for Heather's cover shortly.

Future EdTech Conference June 2019

I have been invited by Future EdTech to take part in their student panel in their June Conference alongside a few more students from different backgrounds. I am hoping this appearance will help the wider education sector understand what studying with the OU means.

Council interview with students and staff

I have taken on this project from Kate Dungate. I have started working with the OU Communications team and the OU's Council to create an engaging interview to help raise the profile of Council both for staff and students. It is intended to be a video piece, which will allow people not involved directly with the Council's work to gain a better understanding of what the Council does and who they are. The aim is to film either in May or July.

REPORT OF VICE PRESIDENT STUDENT SUPPORT

This report covers my role as V P Student Support since January 2019. The Student Support remit generally includes anything that can have an impact on students. I oversee the Peer Support Service and I am a Trustee of OUSET (OU Students Educational Trust).

Peer Support Service

Our lovely Peer Supporters continue to support students during their modules and answer one off queries. The Service is available to all students. If you need a listening ear please look at our site here which gives some information about what you can expect and ways to contact a Supporter. If you are struggling to maintain motivation or have a question you'd like to ask them, last time I looked they didn't bite, so you have nothing to lose by taking that first step and contacting a Supporter.

OUSET (OUSET)

The OU Students Educational Trust is the Association's Charity for students experiencing financial hardship. Details can be found here. Trustees next meeting is on April 9th during which we will hopefully finalise details of our updated Declaration of Trust. Lorraine Adams continues as Temporary Chair.

Service Review Meetings

Service Review meetings discuss matters relating to Academic Services and IT. The most recent meeting was held in January and the next will be at the end of April. Matters under discussion in January included;

- Students can use the new Microsoft Office 365 for non-study purposes during their time with the OU and up to 2 years after. The OU will not be carrying out spot checks. However, Microsoft is able to identify untoward activities.
- Although many of the OU's student facing policies can be found using the search in the Help Centre that is not the case for all of them. However, they are on the Student Policies and Regulations site which can be found via the Help Centre. A direct link is here.
- The OU is aware that there were problems booking tutorials a while ago but they have hopefully addressed these so that it won't be a recurring problem.
- We informed the OU the computer specifications that students should check when purchasing a computer are out of date in some places on their website. This will be looked into and rectified.
- We raised whether .rtf format for submitting TMAs would continue to be accepted and we hope for an update about that in the April meeting.

Student Support

Cherry (V P Equality and Diversity) and I continue to have regular meetings with the OU about the support offered to students. Although there has recently been a change of OU staff we hope these meetings will continue.

Facebook

I continue to be active on Facebook. I followed up a post from a student who wanted to contact other students attending their Graduation Ceremony. Danielle Smith, AAR England, passed on that the OU opens up Facebook Groups for each Graduation Ceremony. Something to look out for if you will be attending your Ceremony. If you are attending a Ceremony shortly, congratulations and have a great day.

S S T / S R S C Roadshow (Student Support Teams; Student Recruitment and Support Centres)

Verity from the Association Office and I continued to give presentations to OU staff. In January we visited the Offices in Cardiff, Edinburgh and Belfast. We were joined in Cardiff by Lucy, A A R (Area Association Rep) for Wales and in Belfast by Wendy, A A R for N Ireland. Unfortunately, Mark, A A R for Scotland, was unable to join us in Edinburgh. We showed OU staff who talk to students what the Association provides which complement what the OU offers. We hope they will share this information with students who contact them. This includes mentioning Peer Support, O U S E T, Clubs, Societies, Meet-ups, the D S G and P L E X U S. More information can be found about these on our website here.

Verity and I have been made very welcome wherever we have given this talk. OU staff were very keen to find out ways the Association tries to help with feelings of isolation. If you recognise that feeling please look at our website to see if anything we offer could reduce that isolation. If you want to organise Meet Ups with other students the Association can help you, the information is on our website.

Edinburgh and Belfast Meet Ups

I was a little nervous hosting Meet Ups for students in Edinburgh and Belfast. My nervousness was partly caused in Edinburgh because both Meet Ups were on the same day and we needed to get on a plane after Edinburgh to host the evening Meet Up in Belfast. I wish I lived in Star Trek world so I could have been instantly transported at the press of a button. Some nerves were around how the meetings would go but I need not have been concerned. The Meet Up in Edinburgh was attended by students wanting to meet other students and covered a variety of topics. The serious study discussion involved planning an experiment to see what impact alcohol consumption would have on study. We also found out quite a lot about forestry. The Belfast Meet Up was more related to issues about study. Meet Ups can be a lot of fun and provide mutual support because we all understand the study experience, including that three letter phrase TMA – Tension Mounting Assignment.

Corporate Parenting Steering Group

This initiative is led by the OU in Scotland, so I can only attend via Skype. The OU is continuing to consider what additional requirements and support is needed by OU students who have experience of being in care. More information, including their Corporate Parenting plan, can be found here. If you would like me to take anything to the group please contact me on the email address at the end of this report.

Corporate Parenting and Edinburgh Hub Launch

I was busy in Edinburgh, despite only being two days. In addition to talking to OU staff and hosting a Meet Up, there was coincidentally a launch of an initiative in Edinburgh to help students, not just those from the OU, who have experience of being in care. The most important part of the evening for me was the four care experienced students who shared their personal stories and experiences, some of which made upsetting listening. I heard that many feel stigmatised and won't let their Universities know they are care experienced in case they were thought of as problem children who had to be placed in care for that reason, rather than due to difficult family backgrounds. It was mentioned that more care experienced people spend time in prison than University. Their education is not helped if they are split from siblings and have to attend many different schools.

Each of the four panel members told moving stories of how at least one person made a significant difference to them. Without them it is possible those four would not have attended University. Our Peer Support Service, is one way we can help care experienced students, with Supporters who can provide that listening ear, motivation, a shoulder to cry on or answer questions.

Jisc Can (Change Agents Network) May Presentation

For about 18 months I was the student representative on a Working Group looking into transforming student policies. The experience was worthwhile because the Project Team listened to what I and other students said and took actions based on that. I made the grave error of heaping well earned praise for the Project Lead in the final meeting and as a result I am now attending the Jisc CAN Conference in May. So, my reward for being nice, is to have the nerve racking experience of standing in front of approximately 60 strangers to co-present with the Project Lead about the positive aspects of this Working Group. The aim is to share with attenders good practice and the importance of listening to students and consulting properly.

Strategy Working Group

The Students Association is undertaking a review of its strategy. One identified thread is supporting students. It is still at the embryonic stage but I am co-lead on that aspect, along with Cherry, V P Equality and Diversity. We are fortunate to have Anna from the Association's Student Support Team as the staff lead. Along with the great enthusiasm she brings – she also laughs at my jokes.

Various Meetings

I have attended various meetings at the OU about TMA extensions and talking about the Student Support Teams. I also attended an AL Training Day to share information about the Students Association.

REPORT OF VICE PRESIDENT STUDENT VOICE

Since the start of this year I have spent more time on campus and attended some very interesting events as well as began some projects which I hope to continue in the longer-term.

We have had two out of the three training events organised by the Student Voice Team for student volunteers, namely a Committee Skills Training Day in January and a Research Symposium in March. The first of these offered C C Rs and S R G members the useful chance to learn more about how to efficiently prepare for and attend meetings as well as report back to the wider student body through reports and blogs. The symposium was an opportunity to hear about research projects currently being undertaken by both the Association and the university which promoted other ways for volunteers to become involved, for example, as student voice researchers. A third training event is currently being planned for June 2019.

The Student Consultation Management Group finalised the topics and questions to be asked at the face to face and online consultations taking place during the Spring. I personally attended the meeting in Manchester on 9th March which resulted in some good discussions surrounding assessment preparation and support, expectations of tutors and advisors, and communications for new students. We also presented the Students Association activities and services, promoting the then-ongoing by-election and collecting feedback and new ideas for student-led projects.

Together with Deputy President Steph Stubbins, I have begun hosting online drop-in sessions for all students focused on student experience. Students are welcome to provide positive or negative feedback on any topic related to their studies which will be collated to raise at the Student Experience Committee and for us to consider other appropriate routes for communication as well as signposting regarding current issues. The first two chats have had small numbers of attendees possibly influenced by technical problems with Adobe Connect, but hopefully numbers will increase as the regular date becomes known. We have also arranged a monthly online drop-in for off-campus postgraduate research students, but so far this has been less popular than the face to face sessions for campus researchers.

My next immediate work is to build upon the strategy weekend held in March to identify key areas and priorities for the Association's next long-term strategy. I shall be co-leading a working group discussing our engagement with the student body. Also in the next weeks I will be attending regular committee meetings as well as a meeting with the chairperson of the Middle States Commission regarding The Open University's re-accreditation in the USA. Following that I have been given the opportunity to lead a session at the **Jisc Change Agents' Network** conference which the university is hosting at the end of May; due the the increase in online tutorials rather than face to face tutition, I will use this opportunity to explore thre possible benefits of feminist pedagogy as a method of improving efficiency in the digital classroom.

REPORT OF STUDENT OU COUNCIL MEMBER

Council Meeting 5 March 2019

Agenda items at the March meeting of Council included consideration of the OU's refreshed strategic plan and proposed success measures, updates on institutional performance, strategic risk and Core Systems Replacement, and reports from a number of Council sub-committees (Governance and Nominations Committee, Remuneration Committee and Finance Committee). There were also confidential items on the AL Contract and FutureLearn.

Points to note:

<u>Updated Strategic Plan.</u>

VCE has identified three key focus areas:

- 1. Improving Student Success through:
 - o supported open entry for all undergraduate provision
 - o improved communications with continuing students
 - the introduction of a robust model for flexible study intensity;
- 2. Core Systems Replacement (CSR)
- 3. Implementation of the new AL contract

Strategic Success Measures

The draft presented to Council did not include any measure of academic support. High quality support is a key element of student success and the comments we are seeing from students about the incomplete or inaccurate advice that they have received from their SSTs suggest that the support offered by the University is less than perfect. In order to monitor (and hopefully mitigate) this, I requested that the NSS questions on academic support should be included as part of the teaching metric alongside the NSS questions on teaching and assessment. The three questions that make up the Academic Support block are:

- I have been able to contact staff when I needed to
- o I have received sufficient advice and guidance in relation to my course
- Good advice was available when I needed to make study choices on my course

Council agreed that this metric should be added to the Strategic Success Measures.

Students Association papers

Council approved the Articles of Association and the updated Relationship Agreement between the University and the Students Association. In addition to some minor changes in wording the updated Relationship Agreement commits the OU and the Association to work **together** over the next year on:

 developing institutional strategies, in particular in relation to the OU's strategic objective regarding Student Success

- developing support for Student Voice
- supporting the Student Engagement Standard Project (previously known as the 'Kitemark' project)
- o the review of academic representation led by the Students Association
- o improving the administration of student representatives' expenses
- the Students Association's Incorporation as a Company Limited by Guarantee

The agreement also includes a new section on the sharing of academic governance and Boards of Study papers which confirms that

- CEC and SRG members should have access to all academic governance papers
- BoS CCRs can share confidential papers with CCRS on the committees above theirs in the governance structure to which the business relates and (unless the Chair or the author of the paper specifically refuse permission) with CCRs on other BoS in the same Faculty.

Council members joined SRG student representatives and Association staff for a buffet lunch before the joint meeting of Council and Senate.

Governance and Nominations Committee (GNC) 6 February 2019

Appointments

A number of permanent and interim appointments to Council and its subcommittees were discussed and recommendations made to Council.

Charter and Statutes Review

The review of the Charter and Statutes has been postponed until after the current review of governance process being led by John D'Arcy and the Academic Governance Review, which began on 1 April.

Evaluation of Council Member Performance

A process for the evaluation of Council member performance was agreed. It will include annual self-assessment questionnaires and biennial appraisal interviews with the Chair or Deputy Chair of Council.

This is the quarterly report for the Area Association Representative for England from January – March 2019.

Committees and meetings
