17. The Trustees may call an extraordinary Conference at any time. The Trustees shall call such a meeting on receiving a requisition to that effect, signed by at least 5 Members of Assembly Executives, each from a different National or Regional Assembly, with the authority of their Assemblies.

With: The Trustees may call an extraordinary Conference at any time. The Trustees shall also call such a meeting on receiving a requisition to that effect from the CEC or a petition signed by a number of students as defined in the relevant bye law.

It also approves the consequent change to Clause 20

Trustees may be elected or appointed to serve up to four terms in total. For the avoidance of doubt these terms may be consecutive or non-consecutive.

70.2 elected Central Executive Committee members for Nations and Regions and/or Faculties; and 70.3 the second student member of the Open University Council.

#### With:

## 70.1 The Central Executive Committee will consist of the following elected members:

- Between 6 and 10 officers with defined remits as agreed by the CEC and Board of Trustees
- One representative for each Nation and Europe not exceeding 6 in total
- Representation from each of the Faculties but no more than one representative per Faculty.
- Other representatives as defined in the bye laws but not to exceed 2 extra
